1 INTRODUCTION

The Incorporated Research Institutions for Seismology (IRIS) is a consortium of over 125 universities dedicated to the operation of science facilities for the acquisition, management, and distribution of seismological data. IRIS facilitates investigations of seismic sources and Earth properties using seismic and other geophysical methods. It promotes the exchange of seismic and other geophysical data and knowledge through pursuing policies of free and unrestricted data access, and fosters cooperation among IRIS members, affiliates, and other organizations in order to advance seismological research and education, expand the diversity of the geoscience workforce, and improve Earth science literacy in the general public.

2 PROJECT DESCRIPTION

The IRIS website (www.iris.edu) is managed from the IRIS headquarter office located in Washington, DC, and runs on a RackSpace Red Hat Enterprise Linux 6.5 (PVHVM) virtual machine. There are several subdomains on the main server, all being managed by separate instances of ExpressionEngine v2 that is running on PHP 5.5.38 and mysql 14.14.

IRIS desires to engage a part-time web developer to migrate existing ExpressionEngine websites and add-ons to current software versions, maintain websites, and develop new applications as requested.

3 SCOPE OF WORK

- Migrate the existing ExpressionEngine website and its add-ons from version 2 to the most current software versions. Several add-ons were built in-house; therefore, code re-writes will be necessary for compatibility with the current version of ExpressionEngine.
- Design, implement, and maintain various IRIS websites. Tasks include analyzing requirements, designing, coding, debugging and testing new features.
- Create, customize, and maintain interactive web applications as requested
- Provide miscellaneous support including basic troubleshooting, interfacing with the outside System Administrator, and interacting with the lead staff Web Developer
- Provide support for an estimated 20-25 hours per week in initial phases, reducing to ongoing maintenance support of 5-10 hours per week, plus occasional projects as needed
- Contractor located in the Washington, DC Metropolitan region is preferred

4 REQUIREMENTS

Working knowledge (3+ years of experience) in:

- PHP v5 to v7, CodeIgniter, ExpressionEngine (including Templating and Add-on development), v 2 and 5
- MySQL
- JavaScript, jQuery
- HTML, CSS (including Bootstrap v3)
- Ability to work at the UNIX command line level
- Git version control

5 SUBMISSION REQUIREMENTS

Technical Submission must include the following:

- Overview of Capabilities/Skills
- Statement of Experience
- Examples of Work Product (e.g. code repository example)
- Two Professional References
- Date of availability to begin work

Financial Submission must include the following:

- Hourly Rate

Please provide an hourly rate and any special pricing arrangements such as a pre-paid retainer contract or a monthly service agreement.

Individuals or organizations who are presently debarred, suspended, proposed for debarment, or declared ineligible for an award or contract by any Federal agency are not eligible to submit a response.

Rights of Retention

Following submission of quotes and final evaluation, IRIS will have the right to retain the responses, maintaining them in confidence. All documents submitted in response to this RFQ shall become the property of IRIS.

6 EVALUATION CRITERIA

Submissions will be evaluated on experience and technical expertise in the following: Expression Engine, PHP, MySQL, JavaScript/jQuery, HTML, CSS Unix and Git version control. Samples of work product must be included. Customer references should also be provided. These references will be contacted during the evaluation process. IRIS will also evaluate contractor availability and cost as part of the process. The final selection will be made on a best-value basis.
